2.0 Eligibility Criteria for Bidders:

2.1 Bids of those Bidders who have not submitted the requisite Cost of bidding document and EMD (as per Instructions to Bidders (ITB) Clause 3.0 & 4.0) shall not be considered for evaluation, except in case of exemption as per Clause No. 3.2 & Clause No. 4.1 of ITB.

2.2 The bidders must fulfill the following minimum Qualifying Criteria:-

2.2.1 Minimum eligibility criteria:

The bidders who wish to apply for the tender for the work mentioned shall satisfactorily establish to meet the following:

- a) Contractor should have valid Incorporation Certificate / Trade Licence Certificate/ Enlistment Certificate / Registration Certificate of appropriate category from PWD/CPWD/MES/Railway or any other state or central Govt. agency or Public Sector undertaking/ Govt. deptt. / Statutory body.

Bidder has to submit Signed and Scanned Copy of partnership deed in case of partnership firm, Incorporation Certificate in case of limited company, ownership certificate/Affidavit in case of sole of proprietary firm and Power of Attorney in favour of authorized signatory in case the firm is not a proprietary firm.

- b) To qualify for award of the Contract, each bidder should have in the last five years ending with last day of previous month "Satisfactorily completed, as prime Contractor, at least one similar work equal in value to 80% of the estimated cost of work or two works equal in value to 50% of the estimated cost of work or three works equal in value to 40% of the estimated cost of works for which the bid is invited". Details of past experience should be provided as per Annexure – IV.

Similar work shall mean R&M Work/ Up keeping Work/ Cleaning Work/Civil Work. **Experience certificate should be notarized.** Sub-Contractor's experience and resources shall not be taken into account in determining the bidder's compliance with the qualifying criteria.

Experience certificate/ completion certificate and copy of letter of awards issued by the State/ Central Deptt./ PSU's/ Private sector Company may be submitted online in support of meeting the qualification criteria.

In case of experience certificates submitted by the bidder, is of Private Sector Company/firm, then Notarized copy of TDS certificate(s) is also required against executed work for which the certificate has been issued.

- c) Copy of affidavit/Certificate of CA mentioning Financial Turnover of last 3 (three) Financial years. Printed Annual reports or financial statements of the Bidder, such as balance sheet, profit and loss statements and auditor's reports as the case may be for the past three years shall be submitted to ascertain bidder's meeting the financial criteria.
- d) Copy of online generated history of EPF Payment of previous year.
- e) Copy of Income Tax Return of previous year.
- f) Certificate for timely payment of salary/wages to workers by 7th of each month from principal employer worked/ working in last 1 year.
- g) A declaration that the information furnished with the bid documents is correct in all respects (Annexure – IX).
- h) Such other certificate as defined in the ITB and required in Tender document. Failure to produce the certificates shall make the bid non-responsive.
- i) All necessary supporting documents shall be submitted online with Technical Bid. Failure to online submission of requisite documents shall make the bid non-responsive.
- j) Self-declaration by the bidder that they have studied and understood all the terms and conditions as mentioned in tender document (including ITB, GCC & SCC) and agree to abide by the same unconditionally is to be submitted. (Annexure – IX).
- k) Bid proforma as per Annexure-V.
- l) ECS Form, duly authorised from the respective bank, as per Annexure – VI.
- m) Duly filled-in Checklist as per ITB Clause 15.0.

2.2.2 All Startups (whether MSEs or otherwise), falling within the definition as per Gazette notification- G.S.R. 501(E) dt. 23.05.2017 are exempted from meeting the qualification criteria in respect of Prior Experience-Prior Turnover subject to their meeting the quality and technical specification. However, the Employer reserves the right to deny such exemptions to Startups (whether MSEs or

otherwise) in case of circumstances like procurement of items related to public safety, health, critical security operations and equipments etc. Declaration of Startups (whether MSEs or otherwise) is to be submitted by the Bidder as per Annexure-VIII alongwith supporting registration document.

2.2.3 All Micro and Small Enterprises (MSEs) are exempted from meeting the qualification criteria in respect of Prior Experience-Prior Turnover in public procurement subject to meeting of quality and technical specifications for which necessary documents shall be submitted by such bidders. Declaration of MSEs is to be submitted by the Bidder as per Annexure-VII alongwith supporting registration document.

2.2.4 The reference date for considering the period for eligibility / qualification requirements above shall be the last day of the month previous to the one in which tenders are invited.

2.2.5 Each bidder must also produce with their Bid – PAN, Goods & Services Tax Identification No. (GSTIN), EPF Registration No. and ESIC Registration No.

2.3 The Bidder should not have been banned / de-listed / black listed / debarred from business or declared ineligible on the grounds mentioned in para 6 of Guidelines on Banning of Business Dealings (Annexure-A) to Integrity Pact ~~[if applicable]~~, ITB Clause 9.0. Self-declaration in this regard is to be submitted as per enclosed Annexure-III.

~~2.4 To improve transparency and fairness in tendering process and/or during execution of work undertaken, the Employer is implementing Integrity Pact as per Clause No. 9.0 of the ITB. The bidder must submit the Integrity Pact as per Proforma (Annexure II) duly signed [if applicable] as per Clause 9.0 of ITB.~~
