# 65 MW Kalpi Solar Power Project

- Purchase Requisition for tendering process through NHPC Ltd. initiated on 28.07.2020.
- NIT for 65 MW Kalpi Solar Power Project floated on 08.10.2020 through NHPC Ltd.
- Approval for award of EPC contract was accorded on 08.03.2021 in 31<sup>st</sup> BoD meeting.
- LoA for 65 MW Kalpi Solar Power Project issued to M/s Refex Energy Ltd. on 17.03.2021.
- Approval for raising of long term loan for implementation of 65 MW Kalpi SSP amounting ₹190.53 Cr on 15.02.2021 in 30<sup>th</sup> BoD meeting.

# **100 MW Mirzapur Solar Park**
